



2016 Pool/Access Control Card (ACS) Registration

(If you obtained a new scannable pool pass in **2015** it will simply be reactivated providing you are in good standing with your assessments and residing at the same address provided on your 2015 application. You will **not** need to reapply for a pass unless you have either moved, lost your 2015 card(s) (and pay the applicable fee(s)), require a nanny pass (and pay the applicable fee) or have children who require a different card based on their age group – Child turning 1, 11 or 18 – All residents wishing to use the pool and other LRR facilities must be in good standing).

The Association issues one access card ("ACS") per resident at no cost. **Replacement cards are \$25 per card and HOA Staff will verify prior Issuance and Usage.** I understand and agree that the ACS card is issued to me personally and I will not allow usage of my card by anyone else and that I am liable for all damages caused by individuals who access a facility through use of a lost card that has not been reported. ***I agree to report a lost card immediately so it can be deactivated.*** I also agree to not bring guests into the pool without a guest pass.

HOMEOWNERS carrying a delinquency in their assessments, or making false representation(s) in connection with facility privileges shall be subject to all remedies available to the Association for violations of the rules and regulations of the Association, including, but not limited to the suspension of my amenity privileges and such other remedies as may be established, going forward, by the Board of Trustees. I also acknowledge and assume the risks associated with the use of the LRR facilities/pools and agree to be responsible for my own safety and the safety of my family and guests who use the facilities and pools on such property. I understand that the safekeeping of my personal property is solely my responsibility and that the Association and its management are not responsible for any damages or loss to personal property.

Proof of residency must be shown for all adults (18 & older) who are not LRR homeowners. A current driver's license, bank statement, utility bill, lease that lists the adult's name as an occupant, or settlement sheet for new owners with corresponding LRR address, will suffice as identification. **Renters must submit a current lease copy before a card will be issued or reactivated.**
